Dear Sirs/Madams,

We refer to the previous correspondence of the ITF Secretary General March 15th, 2023 (attached for ease of reference) informing you that the ITF Board of Directors had decided to hold the 4th Ordinary ITF General Assembly on 5 September 2023 in Tampere, Finland, and that elections will be conducted.

1. Call for elections

a) General

On behalf of the ITF Electoral Committee, I am pleased to inform you that in accordance with Article 34.1 of the ITF Statutes – Edition 2023 (the "ITF Statutes"), the election of the members of the Board of Directors for a four-year term (2023-2027) shall be conducted at the 4th ITF Ordinary General Assembly for the following positions:

- a) President;
- b) one (1) Senior Vice President;
- c) one (1) Vice President;
- d) one (1) Treasurer; and
- e) five (5) members at large.

Enclosed herewith you will find the prescribed Nominations Forms as referred to in Articles 34.7 and 34.8 of the ITF Statutes, and Article 8.4 of the ITF Electoral Code.

Such nomination Forms shall be submitted to the ITF General Secretariat on itfelections2023@itftkd.sport by no later than 24:00 hours (Swiss time) on 4 May 2023.

Articles 34.9, 34.10 and 34.11 of the ITF Statutes provide that:

- A Member Association shall not propose more than one (1) candidate for the positions specified in Article 34.1 (a) to (e)
- No member Association shall be eligible to be represented by more than one (1) member in the Board of Directors.



- If a Member Association proposes more than one (1) candidate for a position in the Board of Directors, or proposes a candidate for more than one (1) position in the Board of Directors, all proposals submitted by that Member Association shall be declared invalid.
- All candidates must be citizens of the country or territory represented by their Member Associations.

According to Article 34.1 of the ITF Statutes, a minimum of 2 (two) of the 9 (nine) members must be female and a minimum of 2 (two) of the 9 (nine) members must be male. For the avoidance of doubt, it should be noted that candidates may be nominated for any Board of Director position, if they fulfil the eligibility criteria for such position.

b) President, Senior Vice President, Vice President, Treasurer (Closed list)

According to Article 34.7 of the ITF Statutes, candidates for the positions listed above and in Article 34.1 (a) to (d), representing the Executive Committee (Article 38), shall be presented in a closed list. Every candidate nominated on the closed list shall be proposed by their Member Association in the prescribed Nomination Form (enclosed) and be supported by at least five (5) other Member Associations.

Such closed list shall be submitted by the Member Association that nominated the candidate for the position of President on the closed list.

c) Five (5) members

Candidates for the positions listed in Article 34.1 (e) "Five (5) Members at large" must be by name and shall be proposed by their Member Association in the prescribed Nomination Form (enclosed) and be supported by at least three (3) other Member Associations.

2. Integrity check

According to Article 10 of the Electoral Code, the IT Electoral Committee shall examine and conduct an integrity check of the candidatures.

In conducting the integrity check, the ITF Electoral Committee is entitled to request the support of an external expert (individual or company).

Each candidate shall complete and sign the Integrity Questionnaire (enclosed) and submit it with the prescribed Nomination Form within the abovementioned deadline.

3. List of candidates

The official list of candidates for the ITF Board of Directors shall be provided to the Member Associations and published on the ITF website in accordance with Article 34.12 of the ITF Statutes.

The ITF General Secretariat will provide you with further details relating to accommodation, transport, official functions, visa requirements and travel arrangement for the 4th ITF Ordinary



General Assembly in due course. In the meantime, do not hesitate to contact the ITF General Secretariat should you have any inquiries.

4. Final remark

The above presented information is for convenience purposes only and consist of a general summery. The full and mandatory requirements, conditions and procedures are those contained at the ITF Statutes and the Electoral Code. - ii. copy of Passport or ID (legible, in PDF or JPG);
- iii. a portrait picture (JPG, 300 DPI)
- iv. the Integrity Questionnaire; and
- v. copy of their Curriculum Vittae and relevant supporting documents.

Annexed Documents form an integral part of this Nomination Form. Annexed Documents shall be provided in English or in Spanish. Where translations are required, they shall be undertaken by an accredited translation service. The original (non-English or non-Spanish) document shall also be provided.
