This is particularly important for large-scale events like prior ITF Taekwon-Do World Championships

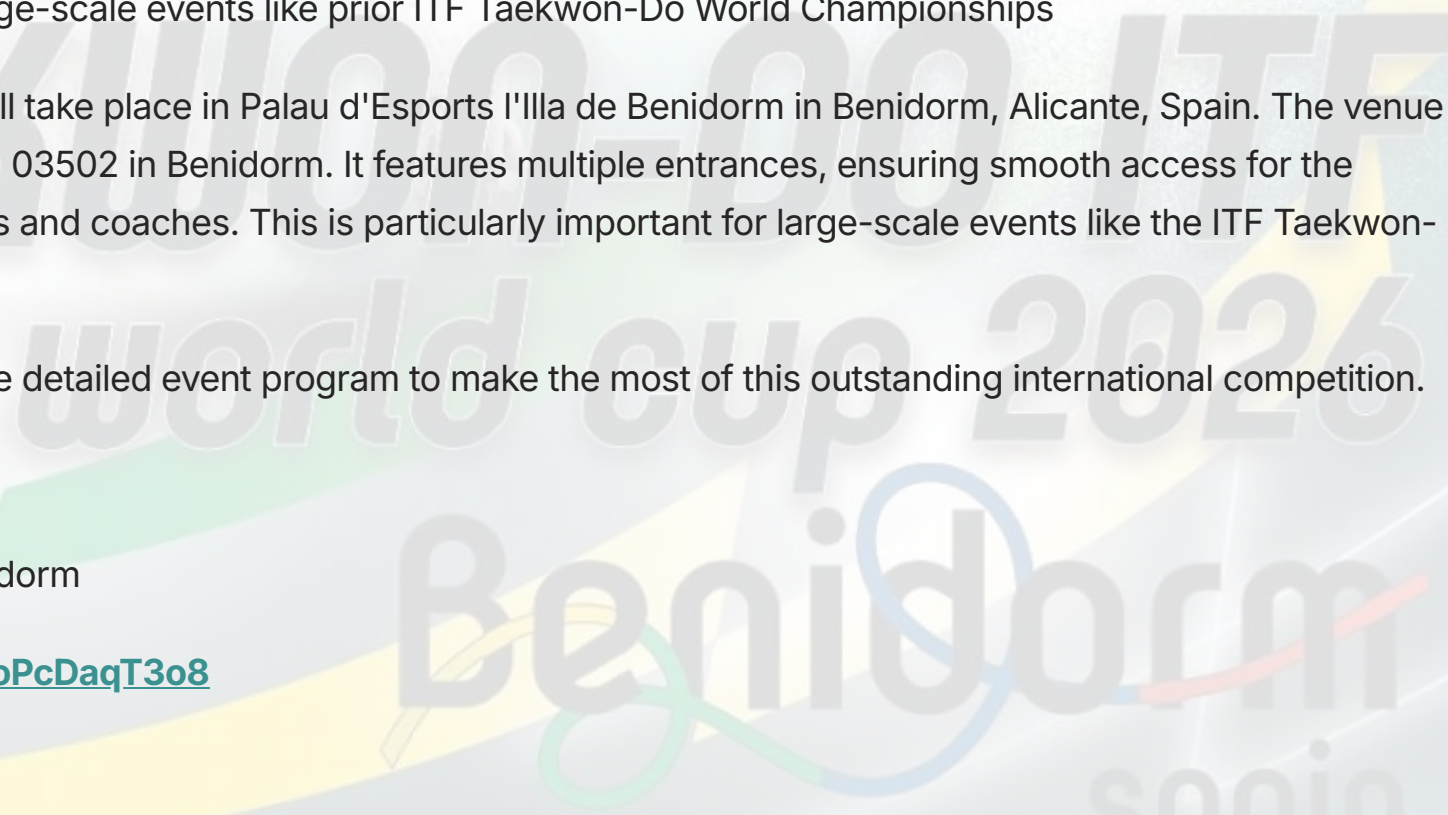

GETTING TO BENIDORM

Airports and Transportation options

Here are the recommended airports and their respective travel times to Benidorm:

Alicante Airport (ALC)

Located just 59 km from Benidorm, this is the most convenient airport.

- By car/taxi: approx. 41 minutes
- By bus: approx. 45 minutes

Valencia Airport (VLC)

Situated 146 km away, this airport offers a good alternative.

- By car: approx. 1 hour 31 minutes
- By bus: approx. 2 hours 27 minutes

Murcia International Airport (RMU)

Located 148 km from Benidorm; this option requires a bit more planning.

- By car: approx. 1 hour 45 minutes
- By public transport: around 3 hours 50 minutes (involving 2–3 bus transfers)

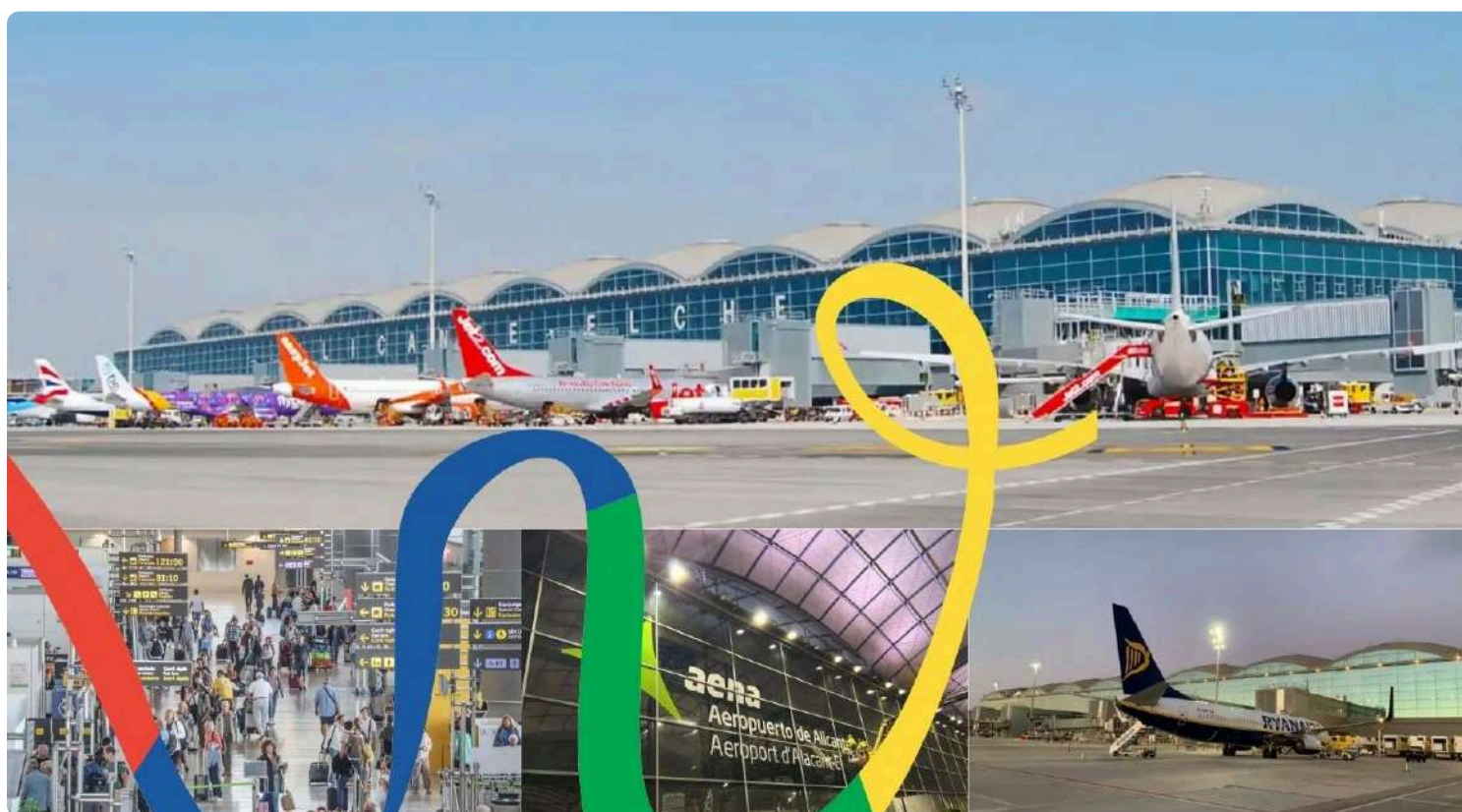
Madrid-Barajas Airport (MAD)

A longer-distance option: 462 km from Benidorm.

- By car: approx. 4 hours 8 minutes
- By train and bus: approx. 4 hours 18 minutes

ONLINE REGISTRATION

All participants – including competitors, coaches, officials, and supporters – are required to complete their registration via Sportdata, managed by the International Taekwon-Do Federation through ITF-Online (data.itftkd.sport).

The registration must be done by each club or organization and will be open from **January 2, 2026** (1:00 UTC) to **August 27, 2026** (21:59 UTC).

Club registration cannot be done directly with Sportdata. Clubs can only access the Sportdata World Cup registration via ITF-Online. Each club should request ITF-Online (data.itftkd.sport) access from their NA.

After the deadline, no registrations or changes will be allowed.

All non-competitors (e.g. supporters, coaches, VIPs) must be registered for the World Cup event to ensure a fully engaged and well-coordinated participation experience for all.

- ❏ NOTE: Please ensure that registration is completed within the designated period. Late registrations, changes, or withdrawals will not be accepted.

VERIFICATION & WEIGH-IN

About one week before the competition, the schedule for the verification & weigh-in will be published.

All Pre-Junior, Junior, Adult, Senior and Veteran competitors must attend the verification and weigh-in on **Monday September 28, 2026** at Palau d'Esports l'Illa de Benidorm, at a time to be determined.

All competitors must be present at the Verification and Weigh-in regardless of the discipline in which they compete.

REQUIRED FOR VERIFICATION

At this time, they must present:

1. Their identification document (national ID or passport)
2. World Championship 2026 official ID cards
3. Declaration of consent and data protection

WEIGH-IN ATTIRE

Competitors must attend the weigh-in wearing ITF-approved dobok pants and a T-shirt.

WEIGH-IN ATTEMPTS

Competitors who do not make weight on the first attempt will have 1 hour for a second and final attempt.

- ❏ If they do not make weight on the second attempt, they will be eliminated from the sparring competition category without the possibility of moving to another category. (see "Official ITF Rules of Competition").

CLOTHING & PROTECTION GEAR

All competitors must use official and approved protective gear and clothing, as indicated in the ITF regulations and the brands and models endorsed by the Federation. You can consult it in the regulations and the ITF website, <https://itftkd.sport/official-equipment/>.

- All sparring competitors must have full protection, head gear, hand and feet safety equipment all in red and blue color, depending on the draw.

ENTRY FEES

Please note that the entry fees are expressed in US Dollars \$.

Note: Limited passes available for photographers.

All participants from non-ITF clubs who wish to participate in the competition will be required to pay the entry fee of 200\$ to receive the corresponding credential.

All competitors registered as a member of a team category (including Team Pre-Arranged Sparring) must also be registered in an individual category. If they do not intend to compete in an individual category, they must register in the "00000 Competitors who only compete as member of a team" category and pay the individual entry fee.

ACCREDITATION FEE

The accreditation fee for competitors, coaches, supporters, VIPs at national level, and photographers at national level are US\$ 170,00. Those who book their accommodation through the organizer have already paid the accreditation fee with their booking and no longer have to pay it.

UMPIRES

The Organizing Committee will cover the hotel accommodation including full board (excluding drinks) from September 27 to October 4, 2026, for a maximum of 100 selected umpires. Umpires will be accommodated in double rooms. Those who wish to have a single room must pay the difference in price.

Other registered umpires who want to participate must pay for their hotel accommodation. For any questions, please contact the official partner Beniconnect.

Mandatory Umpire Meeting

All registered umpires must attend the Umpire meeting on **September 28, 2026** in Palau d'Esports l'Illa de Benidorm.

Dress Code & Attendance Policy

All umpires must be officially dressed as specified in the ITF rules. Registered umpires not present at the Umpire meeting on September 28th will be removed from the list of umpires, and all costs incurred will have to be paid.

Countries selecting or nominating umpires are invited to submit the umpire application form to the Organizing Committee.



Umpire registration and selection process

Step one

All umpires are required to complete their registration via Sportdata, managed by the International Taekwon-Do Federation through ITF-Online (data.itftkd.sport), in the category "Umpire in Request" or IT-Umpire in Request".

Registration must be completed by **March 17th, 2026**, at the latest.

Note: Sportdata request from ITF-Online umpires name, photo, degree and email address.

Step three

The Umpire Committee will select the Umpires and inform them by **April 5, 2026**.

The selected umpires will be moved to the category "Umpires - selected but not yet confirmed."

The Umpires must confirm their participation by **April 12, 2026**. Umpires who wish to stay in a double room with their own accompanying person (105 € per person per day half-board) or in a single room can request this for an extra charge (40 € per person per day).

The NA (or AA in case the NA is not available) will receive an email with the names of the referees from their country. This list must be completed and returned within one week.

Step four

Umpires who have confirmed their participation by email will be moved to the category "Umpires".

Then, the list of selected Umpires to the Organizing Committee by the ITF Umpire Committee.

COACH

There will be an online coach meeting on **September 19, 2026**, at 19:00 UTC under the link <https://teams.live.com/join/9359038544936?p=DwVVm6NxmWDVgWyl6A> and an in-person meeting on **Monday, September 28, 2026** at 8:45 local time.

The coaches are responsible for all their competitors, whether they are competing on the tatami or not. Competitors found in the competition area when they are not called for their competition categories will have their ID card withdrawn.

FREE TRANSPORTATION DURING COMPETITION DAYS

For teams staying in hotels more than 3 km away from the venue, free transport to and from the competition venue after the competition is included in the price. Additionally, Benidorm City Council will provide free public transportation within the city during the competition days. To use this service, participants must present their Event Hotel ID card and scan the associated code.

❏ Please note that the transportation benefits do not apply to teams that do not make their hotel reservations through the Beniconnect agency.

MEDIA AND OFFICIALS PRESS AND PHOTOGRAPHY

Please note:

- All press members must also be registered in Sportdata.
- A registration fee of \$200 applies per photographer.
- Each club may register a maximum of 1 photographer (limited pass available).

❏ NOTE: Early application is recommended due to limited availability. Priority will be given to photographers from the Organizing Committee.



ANTI-DOPING COMMISSION

The AntiDoping commission will be present at the 2026 World Championships and may carry out doping controls.



VISA

If you need a visa, you should contact the Embassy or Consulate of Spain in your country. Please contact the Organizing Committee for any inquiries. To easily check which countries require a visa and which do not, visit the website of the Ministry of Foreign Affairs of Spain <https://www.exteriores.gob.es/>.

The Organizing Committee can send an invitation letter to participating teams that require a visa for Spain, but only upon previous request from the participating teams. They must submit an application, along with copies of the passports of all applicants, a completed Visa application form (Appendix 1), and confirmation of payment of 50% of the hotel accommodation amount by **April 10, 2026**. CURRENCY (€)

The currency used in Spain is the euro. We advise you to exchange money before coming to the Championships. It is also possible to exchange money at any ATMs in the area.

INSURANCE

The Organizing Committee of the 2026 World Championships will not be held financially or morally responsible for any injuries that may occur during the competition.

To ensure adequate protection, it is strongly recommended that all participants are fully insured for the entire duration of their trip. This coverage should be arranged through their respective national federations.

LIABILITY IN UNFORESEEN CIRCUMSTANCES

The ITF World Cup 2026 Organizing Committee does not take responsibility for any damage caused by delays or cancellations of flights or any other unforeseen events.

Therefore, payments made in advance for accommodation and registrations will not be refunded. We suggest arranging complete cancellation risk insurance with your travel agency to cover any unforeseen circumstances.

AFTER PARTY

The World Championship After Party for the competitors will take place at the PENELOPE Disco!! on **October 3, 2026**. Entry is free for all participants over the age of 16 that present their event ID cards.

The official after party will be held at the same venue for adults and juniors. No alcoholic beverages will be sold to junior competitors. Participants over the age of 18 may be asked to show a valid identification document (passport, driver's license, or national ID card) before buying any alcoholic drinks.
